# **AGM UPDATE**

### ANNUAL GENERAL MEETING

Members of **THE DIERI ABORIGINAL CORPORATION RNTBC (ICN 3890)** are advised that the **Annual General Meeting** will be held on **Saturday 19<sup>th</sup> February 2022**. Once again, SANTS have been engaged to facilitate our AGM in 2022.

Sign in at each venue starts at 8:30am (SA time) and closes at 10.00am sharp at the following three locations:

Anyone arriving after 10:00am will not be permitted to enter. Doors will be locked, and entry will be denied. If you attend a venue that is not your specified location according to your address on the membership register you will not be allowed to enter.

You must attend your nearest location due to venue capacity numbers and Covid restrictions.

For example, if you live in Port Augusta or surrounding areas including Quorn, Hawker, Wilmington, Whyalla, Port Pirie, Crystal Brook, Port Lincoln, Ceduna, Marree, Roxby Downs, Woomera, Coober Pedy etc you will be required to attend at West Augusta Football Club.

If you live in Broken Hill or surrounding areas including Swan Hill, Mildura, Berri, Renmark, Barmera, Robinvaleyou will be required to attend at Thyme on Argent.

If you live in Adelaide or surrounding areas, you will be required to attend at Adelaide Royal Coach.

TDAC is committed to ensuring the safety of all members, especially our Elders. West Augusta Football club indoor space will be specifically allocated to our Elders as priority. The Marquee will be set up outside to allow for overflow for all other members attending in Port Augusta.
