

### CREAMY BACON CARBONARA

#### 3 Method Steps:

**Step 1** – Cook pasta in a large saucepan of salted boiling water according to packet instructions. Drain well

**Step 2** – Meanwhile, heat a large frypan over high heat. Add oil, butter, bacon and mushrooms. Cook, stirring for 5 minutes or until bacon is crisp and mushroom is tender.

Step 3 – Add cream. Bring to the boil.

Simmer for 2 minutes or until slightly thickened. Add pasta and cheese to pan. Stir through sauce until heated through. Season with salt and pepper.
